Having spent 23 years on the bench of the Town of Ridgeway Town Court as well as a number of years as Judge of the Village of Medina Village Court, this was not an easy decision to make. Serving as a Magistrate is a sobering experience. Knowing full well that one's decisions not only affect the individuals appearing before you but also the community at large.

It has been a personal honor to serve the Town of Ridgeway, and I trust that my years on the bench have been of benefit to the community.

I am deeply appreciative to the Town of Ridgeway Town Board for appropriating the necessary resources in order to provide an efficient and responsive Town Court.

I shall miss being on the bench, but I recognize that physical infirmities do not allow me to continue to serve. Accordingly, in accord with the provisions of §26 of the Town Law of the State of New York and §31 of the Public Officers Law of the State of New York, I hereby resign, effective November 15, 2014, as Town Justice of the Town of Ridgeway Town Court.

DEPARTMENT AND COUNTY LEGISLATOR REPORT

Attorney, Kathy Bogan, again asked Supervisor Napoli to obtain WD#13 easements from Chatfield Engineers so she can proceed with mailings. Only one easement for WD#13 has been signed and returned.

Assessor Laszewski stated that the exemption renewals will be mailed out soon. Additions will be made to 2015 assessment roll.

Highway Superintendent, Mark Goheen, reported that his highway crew is getting trucks ready for winter weather.

He also said he would be happy to finish up getting signatures on the 3 easements for WD#12.

County Legislator, Lynne Johnson, stated that Orleans County Legislators will hold a Public Hearing on the 2015 County Budget on Monday, December 1, 2014 at 7:00 P.M. in Albion.

Many letters of interest have been received concerning rural broadband. With the passing of proposition #3 on the ballot in November, hope is to get infrastructure and achieve the goal of providing broadband to all rural residents. Legislator Johnson gave kudos to Supervisor Napoli for speaking out loudly in favor of broadband and getting the ball rolling years ago.

COUNCILMAN REPORT

Councilman Blajszczak and Councilwoman Woodruff also congratulated Supervisor Napoli for taking an active part in bringing to light the need for broadband infrastructure.

Councilman Blajszczak also said he was very impressed with Dr. Igoe's new building for Dentistry. It looks exceptional.

Councilwoman Woodruff asked that a letter of appreciation be sent from the Town of Ridgeway to Justice Larry Sanderson.

All board members expressed appreciation for Judge Sanderson's years of dedication and accepted his resignation letter with regret. He will be missed.

BOARD REPORTS: PLANNING, ZONING

Supervisor Napoli, County Planning Board Chairman, said that the County received two referrals and that the Town of Ridgeway had the most number of building permits.

RESIDENTS/OTHER CONCERNS

Owen Toale asked about numbers on the final Town of Ridgeway budget for 2015. He wondered what increase or decrease he should expect on his Town/County taxes. Supervisor Napoli informed him that inside the Village went up .04 and outside the Village went up .07
