MEMORANDUM OF AGREEMENT

THE VILLAGE OF MEDINA, THE TOWN OF RIDGEWAY AND THE TOWN OF SHELBY

Made this 16th day of June, 2014, by and between the Village of Medina, a municipal corporation with offices located at 119 Park Avenue, Medina, New York 14103 (hereinafter, the "Village"), the Town of Ridgeway, a municipal corporation with offices located at 410 West Avenue, Medina, New York 14103, and the Town of Shelby, a municipal corporation with offices located at 4062 Salt Works Road, Medina, New York 14103 (hereinafter, the referred to collectively as the "Towns").

WHEREAS, the Village and the Towns wish to jointly purchase a certain equipment trailer for use by each party; and

WHEREAS, the Village and the Towns desire to memorialize their respective rights and obligations relative to the purchase and use of said equipment trailer.

NOW, in consideration of the foregoing, the parties hereby agree as follows:

- 1. That the parties shall share, equally, any and all costs associated with the purchase of said equipment trailer;
- 2. That the parties shall share, equally, any and all carrying costs associated with the said equipment trailer, including but not limited to, the costs of repair, maintenance, registration and insurance of same;
- 3. That each party shall be solely responsible for any damages which may be
- 4. Caused by, or attributed to, their separate usage of said equipment trailer.

 Moreover, that each party hereby agrees to hold harmless and indemnify the other with respect to any damages which may be caused by, or attributed to, their separate policies of liability insurance which shall adequately protect the respective insuring party from any and all liability which may arise from that party's respective use of said equipment trailer; and

That all parties shall cooperate with respect to the execution of any documents which may be necessary to effect a purchase of said equipment trailer, or any of the other terms set forth in this Agreement.

IN WITNESS THEREOF, this Agreement has been entered into between the parties on the date first set forth above.
