The Public Hearing was called to order by Supervisor Napoli at 7:15 P.M. at which time Supervisor Napoli asked Gabrielle Barone of Economic Development to please address the room regarding the proposed grant.

Gabrielle Barone started by introducing Michael Dobell who filled the position of Jim Whipple who had recently retired

Ms. Barone explained that the proposed Grant would allow Velocitii, LLC to expand their current business. Barone further stated that there have already been 25 to 30 Grant Projects completed and that this would be the third or fourth sponsored by the Town of Ridgeway. The project is geared to help individuals of low to limited income. Velocitii, LLC hopes that with the expansion made possible by the Block Grant it will allow the company to offer 50 new jobs in the community over the next two years. The Company will be investing approximately 1.4 million dollars and the grant/loan would by approximately \$550,000. Once this amount is paid back it will go into a revolving loan fund for the next possible borrowers.

Barone further stated that Velocitii, LLC, is a back-office operation located in building 9 of the old pickle factory. Velocitii answers the phone for skilled professionals and does the bidding to attain jobs for trained individuals.

Ms. Barone asked if there were any question or comments and there were none.

Councilman Woodruff thanked Barone for all the hard work that she does for Orleans County and the Town of Ridgeway.
