RESOLUTION NO. 96-12/30/2021

RESOLUTION AUTHORIZING BOOKKEEPER TO MAKE YEAR END ADJUSTMENTS FOR YEAR ENDING DECEMBER 31, 2021. WHEREAS, THE INDEPENDENT AUDITORS HAVE RECOMMENDED THAT THE BOOKKEEPER REQUEST A “BLANKET RESOLUTION” TO ALLOW FOR ANY BUDGET ADJUSTMENTS THAT MAY BE REQUIRED AT YEAR END; BE IT RESOLVED, THAT THIS TOWN BOARD AUTHORIZES THE BOOKKEEPER TO MAKE THE NECESSARY BUDGET ADJUSTMENTS AND INTER-FUND TRANSERS, AND FURNISH A COPY OF SAID ADJUSTMENTS TO THE TOWN SUPERVISOR WHEN COMPLETED.

RESOLUTION NO. 97-12/30/2021

RESOLUTION TO AUTHORIZE EXTENSIONS WITHOUT APPLICATION OF 2022 PROPERTY TAX EXEMPTIONS ALLOWED UNDER EXECUTIVE ORDER NO. 11. THE 459-c AND 467 EXEMPTIONS MAY BE RENEWED ON THE TOWN’S 2022 ASSESSMENT ROLL WITHOUT A RENEWAL APPLICATION FOR COUNTY, TOWN, VILLAGE AND SCHOOL DISTRICT PURPOSES. THE EXEMPTIONS EFFECTED ARE FOR LOW-INCOME (OVER 65) AND PERSONS WITH DISABILITIES.
