RESOLUTION: LOCAL LAW #1 OF 2025: A LOCAL LAW TO AMEND THE TOWN OF RIDGEWAY ZONING ORDINANCE TO CHANGE SEVEN PARCELS FROM RURAL RESIDENTIAL DISTRICT TO GENERAL BUSINESS DISTRICT ZONING CLASSIFICATION. THE TOWN OF RIDGEWAY'S ZONING ORDINANCE SHALL BE AMENDED AS FOLLOWS: THE FOLLOWING PARCELS SHALL BE REMOVED FROM THE RURAL RESIDENTIAL DISTRICT ZONING CLASSIFICATION AND ADDED TO THE GENERAL BUSINESS ZONING CLASSIFICATION: 48.-2-12, 48.-2-13, 48.-2-42, 48.-2-14.231, 48.-2-14.221, 48.-2-1, AND 48.-2-10. THE ZONING MAP SHALL BE AMENDED TO REFLECT SAID CHANGE OF THESE SEVEN PARCELS.
